





The ALCAEUS Programme is an institutional evaluation framework to assess the degree of COMMITMENT to Sustainable Development Goals (SDGs) in faculties/schools and universities.

The Agenda 2030 certification of these centres within the programme has the main objective of giving visibility to the effort that institutions are making to comply with the SDGs as set out in the United Nations Agenda 2030.

#### ALCAEUS Programme / Agenda 2030

- ➤ ALCAEUS is a voluntary scheme designed to provide visibility to institutions or centres that demonstrate commitment and contribute to the achievement of the UN Sustainable Development Goals (SDGs) / Agenda 2030.
- ➤ It has been inspired by the INQAAHE project 'Making connections between the institutional evaluation and the Sustainable Development Goals'.
- ➤ The pilot run of the Programme is scheduled for December 2020. ALCAEUS will be open to institutions and centres which have successfully undergone an IQAS certification review. It will be based on a SAR and a site visit and will end with an evaluation report.
- > ACPUA will take final decisions and award a quality label for five years. Institutions will submit annual follow-up reports.



## INQAAHE: Making Connections Origin of the programme



Making connections between the institutional evaluation and the Sustainable Development Goals: empowering stakeholders for Quality enhancement









### Aim and characteristics

- The programme measures the centre's commitment to the 2030 Agenda (it does not measure the development of a particular SDG).
- A committed centre includes the development of the 2030 Agenda in its strategic plan, as a line of work down to the different levels of its organisation.
- The actions that the institution develops in response to its commitment to the 2030 Agenda are planned, monitored and their impact is evaluated through its IQAS.
- The staff of the centre are aware of the 2030 Agenda.
- The centre takes into account the 2030 Agenda in its teaching programmes.
- The center sets up alliances and disseminates information on the 2030 Agenda.





### The HEI and the ALCAEUS programme:

- It provides a strategic framework, including the Agenda 2030
- It collects and orders the actions related to the SDGs.
- It opens up a space for reflection and debate within the institution for the purpose of self-evaluation.
- It encourages the community to achieve a common quantifiable goal: external recognition.

The university also obtains a certificate since the moment its first faculty obtains an ALCAEUS certificate.





Any institution or centre with Institutional Accreditation from a quality agency that complies with the ESG can apply for this assessment.







### A panel of experts on Agenda 2030/sustainability will be appointed (from outside the local or regional Higher Education System)

a teaching staff

at least...

- a student
- a professional or external stakeholder
- an international expert
- an ACPUA officer as secretary (non-voting member)

One member of the panel will act as chairperson.

ACPUA Subcommittee on Centre Evaluation (SEC) will be the evaluation body responsible.





### Methodology Evaluation process

- **1. Initial evaluation:** Analysis and evaluation of the documentation provided by the evaluated institution (SAR and evidence).
- 2. Site visit: A visit to the centre by the review panel.
- **3. Initial report:** The visit report, together with all available background information, will be submitted by the panel to the ACPUA Institutional Evaluation Committee (SEC) which will draft the initial report.
- **4. phase:** The initial report will be sent to the institution for comment within 20 days.
- **5. Final report:** After taking in account the statement by the institution, the ACPUA Institutional Evaluation Committee (SEC) may ask the review panel to check the report before issuing the final version. This final report will contain an overall score that will determine the level of certification of the centre.
- **6.** Certification: according to final result.



### **Evaluation protocol**Standars & dimensions


The certification result is based on a **qualitative analysis** of the **evaluation dimensions**, transferred to a **quantitative result**.

A weighting is assigned to each <u>evaluation</u> <u>dimension</u> within the overall <u>evaluation</u> protocol.





### Standards & dimensions



### Weighting

DIMENSION	% SCORE
Dimension 1: Strategy, partnerships and recognition	30%
Dimension 2: Transparency and accountability	15%
Dimension 3: Internal Quality Assurance system (IQAS)	10%
Dimension 4: Programmes (for faculties and institutions)	25%
Dimension 5: Staff	10%
Dimension 6: Funding and resources	10%



# Standards: Dimension 1 Strategy, partnerships and recognition

#### Criterion 1.1: Commitment and strategy of the centre

The centre is committed to the SDGs. The centre defines actions, which it reviews periodically, for the incorporation of the SDGs in its governance, involving the different stakeholders

#### Criterion 1.2: Partnerships

The centre establishes strategic alliances with external partners (higher education institutions, research centres, non-profit organisations, companies, etc.) at local, regional, national or international level that are useful and effective in supporting the integration of SDGs in the centre

#### Criterion 1.3: Internal and external recognition

The practices carried out in the implementation of the SDGs are recognised through internal and external recognition



# Standards: Dimension 2 Transparency and accountability

### Criterion 2.1: Public information

The centre publishes all relevant information concerning the implementation of the SDGs



# Standards: Dimension 3 Înternal Quality Assurance system (IQAS)

### Criterion 3.1: Processes and quality strategy

The centre's Quality Assurance system integrates the SDGs vision as a central commitment

### Criterion 3.2: Staff responsible for the Quality Assurance system

The staff responsible for the Quality Assurance system are trained to integrate SDGs into their work development



# Standards: Dimension 4 Teaching

#### Criterion 4.1: Development of policy frameworks

The centre has developed a teaching strategy aimed to provide knowledge, competences and skills on students due to understand and tackle the SDGs.

### Criterion 4.2: Student-centred learning. Learning outcomes

The programmes "student-centred learning" allow students to acquire learning outcomes (knowledge, competences and skills) related to SDGs, focused on the imparted degrees.



### Standards: Dimension 5 Staff

### Criterion 5.1: Heads of teaching provision / research activity

Those responsible for the centre's teaching provision/research activity are trained to integrate SDG into their academic or research management work

### Criterion 5.2: Teaching and research staff

The centre's teaching and research staff are trained to integrate SDG into their teaching or research activity

#### Criterion 5.3: Administrative and support staff

The centre's administration and support staff are trained to integrate the SDGs into their work



# Standards: Dimension 6 Funding and resources

### Criterion 6.1: Internal and/or external funding

The centre has internal and/or external funding that is allocated to SDG-related initiatives

#### Criterion 6.2: Resources

A capable and qualified team or working group has been set up at the centre to plan, implement and evaluate the initiatives set out in the SDG action plan

ACPUA has finished a **pilot programme** with the two University of Zaragoza schools that have already obtained institutional accreditation:





#### **ANALYSIS**

The panel fully agrees with ACPUA that the ALCAEUS Programme, which aims to raise the visibility of HEIs or centres that carry forward the SDGs, should be widely promoted in Spain and beyond. This is a pioneering scheme designed to enhance the social dimension of higher education, and a flagship example of how the agency responds to the interests and needs of its stakeholders.

**ESG 2.4:** The panel commends ACPUA for involving international experts in all programme reaccreditation reviews.


